## SECTION 4 – FIRST AID MEASURES

## 4.1 – Description of First Aid Measures:

General protection:

Protection of rescue workers: Wear appropriate individual protective equipment (see Section 8). Transport the affected person into the open air. Remove contaminated shoes and clothing.

Inhalation:

## 4.2 – Most important symptoms and effects, both acute and delayed:

Eye contact:

May cause irritation of the eyes (redness).

Skin contact:

Prolonged or repeated contact with the skin may cause irritation.

Inhalation:

May cause coughing (irritation) or irritate asthma. May cause sensitization.

Ingestion:

Ingestion of the product may elicit gastrointestinal problems. May induce vomiting, headache, listlessness.

## 4.3 – Indicate of any immediate medical attention and special treatment needed:
